**Resolution of the International Association of Jewish Lawyers and Jurists**

**“Remember Budapest” Conference**

Budapest, Hungary, 16-19 November, 2006.

1. The International Association of Jewish Lawyers and Jurists (IAJLJ) pays tribute to its Hungarian colleagues who were persecuted and murdered during the Holocaust. It calls on the government of Hungary to release all archival material in its possession regarding the fate of all Hungarian Jews who were deprived of their rights, murdered or deported from Hungary during that period.
2. The IAJLJ calls on all governments and parliaments and the public in all countries to eradicate all manifestations of hatred and bias, including, in particular, the continuing publication in some countries, with tacit government support, of libels against the Jewish people, most notoriously the fabricated Protocols of the Elders of Zion.
3. The IAJLJ demands the implementation of the principles of international law and all legislation concerning the elimination of all forms of racial discrimination and religious intolerance by all countries.
4. Recalling the commemoration by the United Nations of the sixtieth anniversary of the liberation of the Auschwitz death camp, the IAJLJ vehemently protests the statements made by the president of Iran regarding the annihilation of Israel, an independent state, and the organization of a world conference denying the Holocaust.
5. The IAJLJ insists that sixty years after the Second World War and the defeat of Nazism, the world must not accept and must not let these genocidal statements go unpunished.
6. The IAJLJ appeals to the United Nations Security Council and the United Nations General Assembly to implement Article Six of the United Nations Charter, which provides for the exclusion of member states that systematically violate the United Nations Charter.

7. The IAJLJ calls upon the governments of all states to apply to the competent bodies of the United Nations to take action against Iran as provided for in Article Eight of the the Convention on the Prevention and Punishment of the Crime of Genocide to which Iran is a party.

8. The IAJLJ also appeals for the full implementation of United Nations Security Council Resolution 1701 and demands the immediate release of the kidnapped Israeli soldiers in Gaza and Lebanon.

9. The IAJLJ will do its utmost to act in accordance with the principles set out by its founders, the late Justice Haim Cohn, Justice Arthur Goldberg and René Cassin, and their successors, in particular Judge Hadassa Ben-Itto, in defending human rights and international law, in promoting justice and the rights of Jewish communities around the world, and in fighting for the implementation of human rights and civil rights for all peoples.

10. Delegates to the Remember Budapest Conference undertake to bring this resolution to the attention of the governments and parliaments of their home countries and to act for the adoption of the appeals in the resolution by those governments and parliaments.
