



Resolutions of the Election Committee of the International Association of Jewish Lawyers and Jurists (“IAJLJ”) concerning the 14th Congress

- At the first meeting of the Election Committee (“**the Committee**”), held on November 7, 2010, the electoral roll that concludes the names of IAJLJ members who paid their annual dues until October 29, 2010¹ was approved.
- On December 5, 2010, 60 days prior to the Congress, the Committee approved the lists of candidates that was presented to her in accordance to Article 11e. The Committee received one list of candidates for the Executive Committee comprised of candidates to serve as; President, Deputy President, three Vice Presidents, of whom one shall serve as General Secretary, the second shall serve as Treasurer and the third as coordinator for international organizations; and three additional Vice Presidents of whom one is being a representative of a member organization². Three lists of candidates to serve at the Board of Governors were submitted as well. To these lists 50 signatures of support, candidates CVs and their consent to the nomination were added all in accordance to Article 11e of the Articles of Association.
- The Committee found that each candidate submitted his/her candidacy to a specific position as specified in the Articles of Association and that the total number of candidates is in accordance to the number of positions, as states in Articles 10b1, 10b8 and 10c1. Accordingly, the Committee brings the final list³, as specified below, before the Congress for elections.
- According to Article 11f the Committee hereby rules that this list will be published at the IAJLJ’s web site and offices in Tel Aviv and Jerusalem no later than January 7, 2011.
